- 1. Doto Universal LTD, operating under the brand name "Doto", is an International Business Company registered under the laws of Saint Lucia, with company registration number 2025-00369 (hereinafter, the "Company"/ "We" / "Our"). The Company is committed to making our users more satisfied with their browsing experience and has prepared this "Cookie Policy", which provides an overview of how we use the website www.doto.com and to ensure that users (hereinafter "you") are provided with the best service possible with the clearest information on how we use and store cookies.
- 2. What Are Cookies? Cookies are small files that are placed on your device via your web browser when visiting the website. Information is stored, such as the specific preferences when using the website. It is to be noted that you can configure your browser not to save any or only certain cookies on your device. Cookies can also help ensure the marketing you see online is more relevant to you and your interests, and assists with your navigation, additionally they can assist the website users with a more customized web browsing experience, and are not used to determine the personal identity of anyone merely visiting the website.
- 3. Our website (www.doto.com) uses the following types of cookies:
 - 'Session cookies' which are stored only temporarily during a browsing session in order to allow normal use of the system and are deleted from your device when the browser is closed;
 - 'Persistent cookies' which are read only by our website, saved on your computer for a fixed period and are not deleted when the browser is closed. Such cookies are used where we need to know who you are for repeat visits, for example to allow us to store your preferences for the next sign-in;
 - 'Third party cookies' which are set by other online services who run content on the page you are viewing, for example by third party analytics companies who monitor and analyze our web access, for example: Google Analytics, etc.
- 4. How are third party cookies used? The website uses cookies for various reasons, including but not limited to statistical purposes, quality improvement and assurance, verification of identity, location, establishing browser type and device, referral tracking methods, content customization and so forth.
- 5. Your Choice and the Right to Delete and Reject Cookies. You can choose to reject or block all or specific types of cookies set by virtue of your visit to a Doto website by clicking on the cookie preferences on our website. Please note that most browsers automatically



accept cookies. Therefore, if you do not wish cookies to be used, you may need to actively delete or block the cookies. If you reject the use of cookies, you will still be able to visit our websites but some of the functions may not work correctly.
